1. Project Overview

The website shall be simple but having strong mathematical functionality. Site shall be accessible from a Desktop PC, Laptop running latest version of internet explorer, Chrome, Firefox and also from portable devices like Iphone, Androids and Tabs with all security features like captcha (Completely Automated Public Turing test to tell Computers and Humans Apart) code facility. The BIDDER shall also provide a security audit from an authorized certificate authority so that site can be hoisted on State Date Center Servers (J&K). Static Pages shall comprise ergonomically designed "home page" having navigational links to all static and dynamic pages visible to public.

5. Requirements of the Proposal

The areas coved by the proposal in terms of development shall include storing information of the Projects which can be dynamically updated, Project Progress, Project Documentation, Project Tendering, Website User Management, Asset Management, Bank Guarantees Management, Contractor Management, Document Storage and Management, HR Management, File Management and Movement, Feedbacks, Photo Gallery, Monthly Reports, News, etc.

6. RFP & Project Timeline Details

Firm shall submit a work program (computerized in MS Projects or Primavera) in 7 days after signing the contract. The firm will hand over a copy of source code and the database to the client on completion of the project.
