



Subject: - Extension of engagement of vehicles in attached in PMU-JTFRP.



Sanction is hereby accorded to the extension of engagement in respect of vehicles attached in PMU-JTFRP (as per Annexure "A" of this order) for a period of 08 months w.e.f 01.11.2020 to 30.06.2021 (from S. No. 01-11) in Project Management unit (PMU) World Bank Funded Jhelum Tawi Floor Recovery Project (JTFRP) on the terms and conditions mentioned below:

- I. The hiring charges will be paid @27500/-, Rs. 25,000/- & 18600/- for Innova, Scorpio & Taveera respectively on the monthly basis (calander month) excluding fuel, which shall be issued by the PMU.
- II. The payment will be made before 5th day of the succeeding month to the owner /driver of the vehicle on the undertaking of the actual owner made through affidavit.
- III. In case of any breakage/ repair to the vehicle, alternate arrangement shall be provided by the owner.
- IV. The Octrio and taxes, if any payable while on duty will be borne on by the PMU on production of vouchers.
- V. No other claim will be admissible for payment by the Department on account maintenance / repairs of the vehicle during the engagement period.
- VI. The engagement could be withdrawn by the PMU-JTFRP at any time without conveying reasons.


