Subject: Constitution of Economic Re-construction Agency (ERA)

In order to ensure focussed attention on the preparation of Externally Aided Projects, sanction is accorded to the constitution of an Economic Re-construction Agency(ERA). The said Agency will (a) get the projects for external assistance prepared by various Departments, and (b) follow up with various Ministries of the Government of India for getting the projects approved.

The Agency will receive funds for Externally Aided Projects from the Department of Economic Affairs, Ministry of Finance, Government of India, for the implementation of Externally Aided Projects and will furnish accounts to the funding agencies in accordance with the procedures laid down by the said financial institutions /Department of Economic Affairs.

The Agency will be guided by a Governing Body which will consist of the following:-
