## Sub: Starred AQ No. 925 by Sho Javaid Mustafa Mir, Hurble MLA

Will the government please state:

- a. The norms, specifications and mechanism prescribed for execution of the works under ERA and NURAM and
- a. ERA is executing the work under mainly two heads, one is transport sector and another is urban sector. Different subprojects have been awarded under these two heads on National/International competitive bidding system. The contracts are prepared based either on DPR or 'Design as you build' pattern. The BOQ has been framed based on these designs. MORT &H specification has been followed in transport sector with changes in some specifications to suit the project requirement. In urban sector, CPHEO specifications have been followed. In certain cases where these do not apply, CPWD standards or J & K state standards have been adopted. Quality Assurance manual has been prepared for strict compliance of the specifications and ensure quality of the work executed. Drawings have been approved and issued by the Engineer to the contractor for execution as per requirement. Globally accepted and acclaimed FIDIC conditions of contract (1999 edition) has been incorporated in almost all the contracts to deal with the contractual matters arising from time to time during the course of execution. Certain clauses of FIDIC have been amended to suit the project specific requirement. The works are monitored and supervised by the consultants and ERA Engineers. A high level Tender Approval Committee comprising CEO, Directors, Project Managers, DSC and PMC has been constituted to take decisions on all technical and contractual matters.
  - All policy decisions are taken by Governing Body of ERA under the chairmanship of Hon'ble Chief minister, J&K.
- b. Whether these norms and specifications are followed in letter and spirit, if not, reasons there for.
- b. Norms and specifications as prescribed are being followed in letter and spirit.
