Sir,

The following road- projects are proposed in the cities of Srinagar & Jammu under JKUSDIP with ADB funding .

For Srinagar city:

1) Construction Fly over from Jehangir Chowk to Natipora.

The proposed flyover shall have an overall length of about 2.40 Km. with dual carriage-way (4 traffic-lanes) and is estimated to cost Rs.256.66 crore as per the Summary Appraisal Report (SAR) submitted to ADB. This includes cost on account of acquisition of land and structures as also rehabilitation of displaced persons (mostly shop keepers), utility-shifting etc.

For Jammu city:

1) Widening of B.C. Road:

It is proposed to widen the road-sector measuring around 1.90 Km from K.C Chowk to Amphalla Chowk of B.C Road from existing 4 lanes to 8 lanes. The estimated cost of the project is Rs. 43.97 crores as per the Summary Appraisal Report (SAR) submitted to ADB. This includes cost on account of acquisition of land and structures , utility-shifting etc.

2) Fly over from Bikram Chowk to Women College, Gandhi Nagar:

The proposed 4-lane flyover shall have an overall length of 1.25 Km and is estimated cost is Rs. 93.14 crores as per the Summary Appraisal Report (SAR) submitted to ADB. This includes cost on account of acquisition of land and structures, utility-shifting etc.

The above projects shall be taken up for execution on approval by the ADB.
