

URGENT

In view of the ensuing of ADB Mission for the purpose of signing of Tranche – II of Loan – 2 which has completed its first round of inspection and interaction between 24<sup>th</sup> – 30<sup>th</sup> March 2012 and it is expected to be in the State from 9<sup>th</sup> – 13<sup>th</sup> April 2012. Since the signing of the tranche is crucial with respect to start of construction on 9 works spread over 24 contracts of the said tranche. Therefore, following instructions are issued:

- a) Director Central shall liaise with ADB and chalk out minute to minute programme with delineated responsibilities for ERA team at Srinagar and at Jammu for correct briefing/presentation of supply of information to the ADB team.
- b) Director Central to put up status with respect to bid documents of all the projects of Tranche – 2.
- c) Director Safeguard & Institutional Reforms shall liaise with Administrative Departments of Housing & Urban Dev. Department, Planning and Development Department, PHE Department and Chairman Pollution Control Board for preparing an advance draft of timelines for the road map supplied for reforms by ADB viz a viz Loan – 2. Fine detailing of achievements viz a viz the road map done already by the State, those reforms under process and those reforms to initiate should be highlighted by way of a powerpoint presentation to be made before the ADB team.
- d) Director Safeguard & Institutional Reforms shall issue a meeting notice which is scheduled to held on April 12, 2012 at 1200 hrs. for by-party interaction between six members of ADB team and Administrative Secretaries of H&UDD, Planning, PHED and Chairman PCB on the issues mentioned in note sub-para (c). All Directors of ERA to be present during the meeting.
- e) Director Safeguard & Institutional Reforms shall prepare a white paper on the detail status of rehabilitation viz a viz of Tranche – 2 projects with special focus on flyover at Jehangir chowk, Srinagar and Bikram Chowk at Jammu.

- f) Director Safeguard & Institutional Reforms shall also put up status of submission and consequent approval by ADB of RPs and IEEs with respect to all the projects under Loan – 2.
- g) Director Finance is directed to peruse the original loan agreement and the terms & conditions of agreement with respect to signing of Loan – 2. She may also put up a concept paper on the expenditure under 2011-12 with respect to Tranche – 1 of Loan – 2.
- h) Network Administrator shall keep ready a detailed presentation on all the above matters including reforms road map and presentation of water supply scheme from river Chenab to Jammu city for ADB on 13<sup>th</sup> April 2012 during warp up. He should also keep the record of all deliberations with the ADB team both at Jammu and Srinagar.
