## Assignment of duties/work distribution for Tranche - III of Subject: Loan - 2.

In view of the tentative approval of all shelves of works for Tranche - 3 of Loan II by the Hon'ble Chairman, ERA/Hon'ble Chief Minister it is imperative that immediate work on finalization of DPR leading to SAR for various identified works to be initiated. The work of the Loan – II, Tranche - 3 shall be executed through following distribution:

- a) Water Supply Scheme Jammu city to river Chenab: Director Urban Shri O.P. Dubey is hereby execute and supervise all activities associated with the said sub-project in addition to his own duties already assigned to him. Further, Project Manager, Shri S. L. Kapoor is hereby given charge of Project Manager for the said sub-project.
- b) All identified projects of Srinagar including sewerage and drainage under Tranche – 2 of Loan – II: Director Central Shri Khalid Muzaffar shall hereby execute and supervise all activities associated with the said sub-project in addition to his own duties already assigned to him. Further, Shri Andrabi, Project Manager, is hereby given charge of Project Manager for the said sub-projects.
- c) Shri Vinod Sharma, Director SG&IR in addition to his duties already assigned to him is hereby given responsibility for conceptualization /designing /preparation of DPRs/SARs and such allied activities pertaining to negotiation of a fresh Loan - 3 with ADB subject to the approval of Governing Body in the sectors of energy, Transport, Urban and Tourism etc.

The team shall immediately prepare detailed timelines as discussed with the ADB Mission on sidelines of its recent mission (24<sup>th</sup> March to 13<sup>th</sup> April 2012) and initiate all activities relating to signing of Tranche - 3 of Loan - II on or before June 2013.
