## Invitation for Bids

Date: 11.02.2019.

For and on behalf of Hon'ble Governor of J&K State, sealed bids are invited from eligible bidders for the works mentioned below:

1. **NAME OF WORK:-** “Balance work for Construction of Surface Water drainage system in Athwajan Catchment on National Highway Bypass at Srinagar which includes (i) Supplying, laying & jointing of RCC NP<sub>3</sub> class pipes of dia. 400 mm to 1400 mm for drainage system including construction of R.c.c. manholes (ii) Drainage pumping station including supplying, erection, testing, commissioning and all allied civil, electrical & mechanical works along NHbypass, at Athawajan-Pantha Chowk Srinagar”.

**Deadline for submission of Bids: 1500 hrs on 25.02.2019.**

**Time of completion 3 calendar months.**

2. The work will include providing and laying of RCC NP<sub>3</sub> class S&S pipes ranging from 400mm dia. to 1400 mm dia including construction of RCC manholes and drainage Pumping station including supply, erection, testing, commissioning of vertical turbine pump sets, motors, valves and associated civil, electrical & mechanical works at Athwajan, Srinagar.
3. To be qualified for the contract, the bidder should have working experience of ADB funded projects and the bidder should meet the following requirements: (a) average annual construction turnover for last three years equal to or more than INR 80.00 million; (b) successfully or substantially completed at least one work contracts of drainage pipeline and water/waste water pumping station works within the last five years, each with a value of at least INR 50.00 million under ADB funded projects c) should have executed atleast one contract of Drainage pipeline works of size 300 mm to 1400 mm dia for a minimum length of 1.5 Km and construction of sewerage or drainage pumping station including all the electromechanical works.  
However for complete eligibility and qualification requirements, bid document should be referred.
5. Competitive Bidding will be conducted in accordance with Single stage; two cover bidding procedure and is open to all bidders.
6. The Bidding Document in English language, may be purchased by interested Bidders on submission of a written application to the Project Manager (hyd), PIU, Economic Reconstruction Agency, Srinagar on payment of a non-refundable fee of Indian Rupees 10,000/- (Rs. Ten thousand only) starting from 14.02.2019 to 22.02.2019 The method of payment will be through demand draft in favour of Project Manager J&K Economic Reconstruction Agency, payable at Srinagar.

7. Interested eligible bidders can visit site and obtain further information from office of the Project Manager (hyd), PIU, Economic Reconstruction Agency, Srinagar, from 1100 to 1600 hours on all working days.
8. Bidding document is also available on project website [www.jkera.org](http://www.jkera.org). Eligible interested bidders can see and download the document and can participate in bidding procedure. Such bidders will submit cost of bidding document along with technical proposal through demand draft in favour of of Project Manager J&K Economic Reconstruction Agency, payable at Srinagar. No bids will be entertained without cost of bidding document.
9. Bids must be delivered at the address given below before 1500 hrs on 25.02.2019. Technical bid must be accompanied by a Bid Security of INR 2.00 millions. Late bids shall be rejected. Technical bids will be opened on the same day in presence of the Bidders' representatives who choose to be present at the address below at 1530 hrs.
10. The Economic Reconstruction Agency will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of Bids.
11. Pre-bid meeting with the bidders shall be held at the office of Project Manager, Srinagar at 1100 hrs on 18.02.2019.
